

"Improving CPR Competence with Digital Education – An Intro to RQI" Webinar Questions & Answers

1. Is there specific RQI equipment, what cost?
a. All RQI equipment is included in the subscription cost. There is no
capital purchase for equipment. RQI Simulation Stations are owned
and maintained by RQI Partners and the Irish Heart Foundation.
2. How can we be sure it is the correct person doing the online skills session?
a. All learners have a unique user ID that should not be shared, similar
to any other eLearning that is delivered. Organizations should
leverage existing policies.
3. Is there a recommended ratio of RQI stations: staff?
a. When planning your RQI Implementation a ratio of 1 RQI Simulation
Station per 250 learners is used as a starting point.
4. Do candidates need to complete any other training e.g. HeartCode or is RQI
all encompassing?
a. RQI is an all-encompassing solution for Basic Life Support.
5. We have 70 staff that require training is that a smaller number than usual
to subscribe?
a. That is on the smaller side, but we have had organizations that size
begin RQI.
6. Does it take much space to keep the equipment, specially if we don't have
skills sessions in each area?
a. The RQI Simulation Station dimensions are Width 64,1 cm, Length
137,2 cm, Height 101,6 – 154,9 cm*, Weight 101,2 kg. *The height
depends on the position of the laptop arm with the laptop being
opened.
7. How long does it take to complete the simulation station training?
a. Prep eLearning is around 45-60 minutes once in the beginning,
quarterly sessions are about 8-10 minutes at the RQI Simulation
Station, and about 10 minutes to complete quarterly eLearning.
8. How is AED covered in this programme?
a. AED is covered withing the eLearning. If specific hands-on AED
training is required, we encourage you to compliment the RQI
programme with it as needed for your organization.
9. Any suggestions on when to assess AED skills?
a. That would be based on any requirements from your organization.
10. If one RQI was purchased for approx. 250 staff, roughly what price are we
talking?

a. Each quarterly session is the same amount of time except for when		
learners are in session 4 of the curriculum. They will complete a		
baseline assessment (core skills without feedback) annually to		
measure retention of high-quality CPR skills.

a. There are no advanced airway requirements in Basic Life Support.
