ACLS for Experienced Providers (EP) Course Outline

The ACLS for Experienced Providers (ACLS EP) Course aims to expand ACLS knowledge beyond the standard primary and secondary survey and to give the learner a systematic approach to identifying and treating the underlying causes of cardiac arrest. Case based scenarios are used to move beyond the algorithms and show learners how to apply critical thinking to quickly reach a differential diagnosis and effectively manage treatment. The course aims to improve outcomes in complex cardiovascular, respiratory and other (e.g. metabolic, toxicology) emergencies by expanding on core ACLS guidelines and encouraging critical thinking and decision-making strategies. Through instruction and active participation in case-based scenarios, learners enhance their skills in the differential diagnosis and treatment of prearrest, arrest and post-arrest patients.

Please note that learners are expected to enter the course with solid knowledge of ACLS skills and treatment algorithms.

Course Content:

The course is one day in length and conducted in a classroom based, instructor led environment. Please see *Appendix 1* for the approved course timetable. The course includes standard ACLS assessments which all candidates must successfully complete. These include:

- ACLS written exam
- · Airway management test and High Quality BLS test
- High Performing Team (HPT) Megacode test
 If the candidate is unsuccessful they can't proceed to the next level.

Following successful completion of the above assessments, students participate in case based group discussions for four different learning stations which include:

- Cardiovascular
- Clinical pharmacology and toxicology
- Respiratory and metabolic
- Post cardiac arrest care learning stations

Each of these learning stations uses cases selected from 68 scenarios based in either prehospital, emergency department or in-hospital settings. This helps ensure the course can be customised to best meet the needs of students. Although participants are not tested on these four learning lessons, they are required to actively participate during these discussion scenarios.

The ACLS EP Course teaches the following:

- Applying the expanded systematic approach (ACLS EP Survey) to patient assessment, evaluation and management
- Cardiovascular emergencies
- Cerebrovascular emergencies
- Respiratory and metabolic emergencies
- Post-cardiac arrest care
- Clinical pharmacology and toxicology emergencies
- High quality CPR
- Effective team communication within a resuscitation team and recognition of the impact of team dynamics on overall team performance and patient outcome

Target Audience:

The ACLS EP Course is designed for seasoned healthcare providers who are proficient in performing BLS and ACLS skills, reading and interpreting ECGs, understanding ACLS pharmacology and those who regularly lead or participate in emergency assessment and treatment of pre-arrest, arrest or post-arrest patients. As the course covers a number of advanced skills and topics a good level of knowledge and a clinical background involving resuscitation is necessary for students to be able to participate in this course.

The formal skills assessments of the ACLS EP Course include Airway Management, High Quality BLS and HPT Megacode Test along with the ACLS written exam. However, it is useful to note that the learning stations within the course require candidates to participate and contribute during the case based scenarios but there is no formal exam on these lessons.

The course provides an alternative for those wishing to recertify as an ACLS Provider such as Critical Care Nurses, Registrars, Consultants and any individual expected to lead in a cardiac arrest or other life threatening scenario. Those without the appropriate experience may find the standard ACLS Provider Course, Heartcode ACLS or ACLS Recertification Courses more suitable to recertify their skills.

Teaching Faculty:

The ACLS EP Provider Course may only be taught by Instructors who hold current ACLS EP Instructor Certification. Any Training Site Coordinator who wishes to verify an Instructor's certification prior to a course can contact the Irish Heart Foundation directly to check these details.

The maximum Instructor – Student ratio required for the ACLS EP Provider course may vary across the timetable as follows:

- All skills testing stations must have a maximum Instructor Student ratio of 1-3
- The Learning Stations must have a maximum Instructor Student ratio of 1-6

The Irish Heart Foundation conducts ACLS EP Instructor Workshops for ACLS Instructors who wish to gain ACLS EP Instructor Certification. Places on these workshops are strictly limited and are by nomination from Training Sites which have committed to conduct ACLS EP Courses.

ACLS EP Course Medical Director:

Each ACLS EP Course must have a course Medical Director (MD) who is present onsite for the duration of the entire course. The presence of the MD is mandatory due to the Instructor – Student ratios used on the ACLS EP Course.

The Medical Director on an ACLS EP Course must meet the criteria for being an ACLS Course MD and <u>also</u> hold current ACLS EP Instructor Certification. Please note that the MD may also act as an instructor while acting as MD for the course.

Pre-Course Self-Assessment:

Candidates should complete the ACLS Precourse MCQ.

The ACLS Provider Exam is a compulsory element of the course to be completed by candidates but can be done in the classroom using the standard ACLS written exam which sites already have.

Pre Course Requisites:

Course participants are expected to have the following skills and qualities:

- Be proficient in performing BLS and ACLS skills (and if they do not hold current ACLS certification they must hold current BLS Provider)
- Be able to read and interpret ECGs
- Have an understanding of ACLS pharmacology
- Regularly lead or participate in emergency assessment and treatment of pre-arrest, arrest, or post arrest patients
- Use key elements of critical thinking in processing information and data in development of the differential diagnosis and decision-making for intervention and care.

Candidates may attend the ACLS EP Provider Course without holding <u>current</u> ACLS Provider Certification however the Irish Heart Foundation would strongly recommend that candidates have done an ACLS Provider Course at some stage, even if they are not currently certified.

Where a candidate does not hold current ACLS Provider Certification they must be currently certified in the BLS Provider Course or equivalent (e.g. CFR Advanced Certification). A copy of their current ACLS Provider or BLS for Provider (or CFR Advanced) Certification should be presented to the Training Site Coordinator prior to the ACLS EP Provider Course.

There is deliberately no skills practice time in the ACLS EP Course as students must come to the course with a solid foundation in ACLS and should come to the ACLS EP Course prepared to be tested in ACLS Skills. These assessments include CPR AED, bag-mask ventilation and megacode along with the ACLS Provider written exam. If the student is unsuccessful they must not proceed to the next stage of EP course.

Students who do not hold current ACLS Provider Certification must pass all necessary skills High Quality BLS Testing, Airway Management bag mask ventilation and HPT Megacode testing and the ACLS written exam <u>without remediation</u>. If they do not pass any of the skills assessment or the written test on the first attempt, they should be referred back to the full

ACLS Provider Course and may not proceed further in the ACLS EP Course. **No exceptions to be made.**

Candidates holding current ACLS Provider Certification who attend an ACLS EP Course may be offered remediation.

It is vital that candidates who do not hold current ACLS Provider Certification are informed of this course requirement in regard to remediation in the pre-course letter sent to them prior to attending the ACLS EP Course.

Please remember that the ACLS EP Course is intended for the experienced ACLS Provider so some candidates may be more suited to recertifying their skills on the ACLS Provider, ACLS Recertification or ACLS Heartcode Courses where more skills practice time is provided.

Course Completion Requirements for Students:

In order to successfully complete the ACLS EP Course students must complete all of the following requisites to receive ACLS EP Provider certification:

- Attend the entire course and actively participate in all case based scenarios and must meet all current ACLS course completion requirements including:
 - Pass current ACLS Provider Course exam with a minimum score of 84%
 - o Pass the High-Quality BLS skills test
 - o Pass Airway Management skills test
 - o Pass High Performance Teams Megacode skills test

Students who successfully complete the course will receive an ACLS EP Provider electronic certificate which is valid for two years. The ACLS EP Provider Certification supersedes ACLS Provider Certification.

Written Exam

Candidates must complete the standard ACLS Provider Course Written Exam. This should be conducted either:

 Online and results presented to course coordinator prior to starting the ACLS EP Course

OR

• In the classroom setting at the very start of the course

If candidates are to do the online version of the ACLS Provider Course Written Exam then the course coordinator will need request Exam from resus@irishheart.ie

NB: Any candidate that does not successfully complete the ACLS Provider Course Written Exam may not continue with the ACLS EP Provider Course and should be directed to attend and complete a standard ACLS Provider Course.

Modular ACLS EP Training:

The format of the ACLS EP timetable lends itself to being conducted on a modular basis in a hospital setting. In doing so the course may be conducted on a weekly basis with week one being the ACLS assessments and written exam and then each of the following weeks containing a different learning station (cardiovascular, clinical pharmacology and toxicology, etc.). For consistency the **same medical director** should be present for each session and the course must be completed within a maximum 8-week timeframe in order to obtain IHF certification. If you are interested in conducting the ACLS EP Course in a modular way please contact the Irish Heart Foundation before making any plans, as the timetable for the planned modular format must be approved by the Foundation before proceeding.

Post Course Paperwork:

The ACLS EP provider post course paperwork should be submitted to the Irish Heart Foundation within 30 days of the course. This should include the following information:

- · Course timetable with faculty noted against each lesson
- Course Roster including signed Faculty
- Course Roster Result Sheet including signed list of candidates with results for each assessment – see Appendix 2 for an example results sheet
- Course Checklist
- CSV file for Electronic Certificates

Sites Who May Conduct ACLS EP Courses:

Only Training Sites with prior approval to conduct ACLS courses may offer ACLS EP Courses. These Training Sites must give the Irish Heart Foundation at least 4 weeks' notice of any planned ACLS EP course dates. If requested, the course may also be advertised on the Irish Heart Foundation's website at www.irishheart.ie/aclscourses.

ACLS EP Instructor Courses

These courses will be Co-ordinated by the IHF, you become EP instructor you must be an ACLS instructor for at least 2 years or taught on 4 ACLS courses. If this is your first course as an EP instructor you will need to be monitored by faculty or medical director of the course.
