Foras Croí na h-Éireann Background and Introduction to ACLS

The ACLS guidelines were first published in 1974 by the American Heart Association, and have been updated in 1980, 1986, 1992, 2000, 2005, 2010, 2015, 2020 and most recently in 2025. The chain of survival was first introduced in 1991 as a model of efficiency and synergy in resuscitation efforts. In 1995 the Irish Heart Foundation (IHF) became the first International Training Centre to offer Basic Life Support, Advanced Cardiovascular Life Support and Paediatric Advanced Life Support programmes.

Before 1995, there was no standardised approach to Advanced Cardiovascular Life Support training in Ireland. Over the ensuing years, it has become clear that to improve outcomes from cardiac arrest, systems must be in place. Advanced Cardiovascular Life Support (ACLS) impacts multiple key links in the chain of survival, that include interventions to prevent cardiac arrest, treat cardiac arrest, and improve outcomes of patients who achieve Return of Spontaneous Circulation (ROSC) after cardiac arrest. Resuscitation efforts may be complex and unpredictable. Indeed, a good resuscitation team has been compared to a fine symphony orchestra. The team requires a team leader with broad skills in organisation and performance, and individual team members for specific performance skills. Like an orchestra, all are performing the same piece, polished by practice and experience, with attention to both detail and outcome. There is no excuse for a disorganised or frantic code scene.

Effective management of a patient in cardiac arrest requires this team-based approach with providers who have the knowledge, clinical skills, interpersonal communication skills and leadership skills to perform effectively in a high-stakes environment. This also requires a team leader who can provide oversight of the team, as well as guidance for specific tasks, and maintain a heightened level of situational awareness to avoid fixation on individual aspects of care. Given that team-based skills are different from clinical care skills, specific team and leadership training may have a role in the effective performance of resuscitation teams, and in

turn patient outcomes after cardiac arrest.

To maximize learning from Advanced Cardiovascular Life Support training courses, provider candidates should be well prepared before attending. Similarly, instructors have the responsibility of providing an optimal learning environment that will facilitate the acquisition and refinement of skills for motivated trainees.

ACLS Course

Course Overview and Design: (AHA ACLS Instructor Manual 2025)

Scientific evidence has pointed the way toward better content while educational research has led to improved design of the Advanced Cardiovascular Life Support Provider Course (ACLS). Both the design and the content of the AHA ACLS Provider course are evidence based.

The ACLS Provider Course is designed for health care professionals who either direct or participate in the management of cardiac arrest, stroke or other cardiopulmonary emergencies. Through instruction and active participation in simulated cases the student will enhance their understanding in the recognition of time -sensitive intervention of cardiopulmonary arrest, post cardiac arrest, acute dysrhythmia stroke and acute coronary syndromes.

The ACLS Provider Course emphasizes three concepts:

- The crucial importance of high-quality CPR and early defibrillation to patient survival
- The integration of effective BLS with ACLS interventions
- The critical importance of effective high-performance team interaction, timing and communication during resuscitation

High-performance teams effectively incorporate timing, quality, coordination, and administration of the appropriate procedures during a cardiac arrest (Figure 1). These 4 key areas of focus include the following specifics:

- **Timing:** time to first compression, time to first shock, optimizing CCF, minimizing preshock pause, and early emergency medical services (EMS) response time
- **Quality:** rate, depth, complete recoil; minimizing interruptions; switching compressors every 2 minutes or sooner if fatigued; avoiding excessive ventilation; and using a feedback device
- **Coordination:** team dynamics; team members working together, proficient in their roles
- **Administration:** leadership, measurement, continuous quality improvement, and number of participating code team members

Teams function differently in different facilities and in all out-of-hospital settings. Knowing the policies and procedures and the local protocols of your classroom audience is essential to instructor preparation.



The course is designed to give students the opportunity to practice and demonstrate proficiency in the following skills used in resuscitation:

- Systematic approach
- High Quality BLS
- Airway Management
- Defibrillation
- Intravenous IV/Intraosseous access IO
- Use of medications
- Cardioversion
- Transcutaneous Pacing
- High Performance Teams

Course Objectives

After successfully completing this course, students should be able to:

- Define systems of care

- Apply the BLS, Primary and Secondary Assessments sequence for a systematic evaluation of all adult patients
- Discuss how the use of rapid response team (RRT) or medical emergency team (MET) may improve patient outcomes
- Discuss early recognition and management of ACS
- Discuss early recognition and management of Stroke
- Recognise and treat bradycardias and tachycardia's that may result in cardiac arrest or complicate resuscitation outcome
- Model effective communication as a member or leader of a high-performance team
- Recognise the impact of team dynamics on overall team performance
- Recognise and perform early management of respiratory arrest
- Recognise Cardiac Arrest
- Perform prompt high quality BLS including prioritizing early chest compressions and integrating the AED
- Perform early management of cardiac arrest until termination of resuscitation or transfer of care, including post-cardiac care
- Evaluate resuscitative efforts during a cardiac arrest through continuous assessment of CPR quality, monitoring the patient's physiologic response and delivering real time feedback to the team.

Variations of ACLS Courses (AHA Instructor Manual 2025)

Educational Design:

The ACLS Course uses a variety of teaching methods and adult learning principles that in some cases will simulate or may actually be a real healthcare setting. From an educational perspective, the closer the simulated emergency is to real life (setting, equipment), the better the transfer of skills. Simulation has been the fundamental educational model for ACLS for more than 20 years. Simulation offers students the opportunity to learn and practice their cognitive and psychomotor skills before applying them to real patients. There is ample evidence from many disciplines to support the effectiveness of such simulation-based education in improving participant knowledge, skills, team performance, leadership

and communication. For this reason, the ACLS course continues to incorporate this model in its design.

The AHA provides a range of experiences to engage different types of students with various learning styles, with a common goal of optimizing performance in real emergencies and saving lives. To maximize student learning and retention, scenarios can be tailored to fit specific locations.

Different course and program formats are available to accommodate the learning needs of individual training of students and offer flexibility for instructors:

- *Instructor led ACLS*
- *Heartcode ACLS*
- *Instructor led ACLS for Experienced Providers*

Instructor Led ACLS Training

- In Instructor led training, precourse preparation is required so that students are prepared for the course at the training site.
- The training coordinator may choose for students to complete online video lessons before class, or may choose to run a traditional ACLS course where all the videos are conducted in class.
- Core concepts are presented online through video lessons, instructor led discussions, and case base scenarios around a manikin
- The instructor coaches students by using a feedback device as they practice CPR and ventilation skills
- The instructor monitors each student demonstrating skills proficiency as outlined in the skill checklist
- Students take an exam to understand the core concepts

Blended Learning Heartcode

A blended-learning course is structured as follows:

- Core Concepts are presented in an online adaptive interactive format using the Heartcode program. The online course is self directed, the student controls the time, place and pacing of instruction.
- After successful completion of the online portion, students print a certificate of completion.
- Students then go to a Training site for the hands on session. If a certificate of pre course completion is not presented on the day of the course the student cannot attend this part 2 segment.

To ensure that students have prepared for the course they must pass the pre-course self-assessment with a score of 70% or higher. After taking the pre-course self-assessment and completing the video lessons, students must print out a copy of their certificate indicating their score on the pre-course self-assessment and completion of all videos and bring it to the class.

ACLS Provider Course

Who is this course suited for?

The Advanced Cardiovascular Life Support (ACLS) Provider Course is designed for healthcare providers who direct or participate in the management of cardiopulmonary arrest, or other cardiovascular emergencies.

Course Delivery

Instructor led hands on classroom format reinforces skills proficiency.

Through active participation and instruction in simulated cases, this course will upskill healthcare professionals' knowledge through the emphasis of the three major concepts of ACLS.

Before the course, participants must study the ACLS provider manual, complete the pre-course self-assessment module, and all pre-course work on the student website.

(Depending on the delivery of the course whether it runs with the traditional method where all videos will be shown on the course or whereby the student previews the pre-course work videos prior to attending the course)

The candidates must remediate any gaps in their knowledge by studying the content in the ACLS Provider Manual or supplementary resources. This course normally runs over two days.

ACLS Recertification Course (ACLS Update Course)

Who is this course suited for?

The ACLS Update Course is for students who have a current ACLS Provider certificate and need to update and refresh their ACLS skills.

Course Delivery

This course is primarily focused on skills and competency testing.

This ACLS course has been designed for individuals with **current** ACLS Provider Certification that is due to lapse soon, and who wish to renew their certification.

The recommended renewal period for all ACLS courses is two years, so candidates can only attend this one-day course if they hold a current ACLS Provider certification at the time of attending the course.

NB: ACLS Providers whose certification has lapsed may now attend a recertification course within 3 months of their certification expiry date. Unfortunately, no extension can be given beyond this date for this course.

ACLS Heartcode (Blended Learning)

Who is this course suitable for?

This course is more suited for those who have previously taken the ACLS Provider course. Clinical experience and previous exposure to cardiac arrest and pre-arrest cases is desired for taking this course. This course is an excellent way of updating and recertifying your ACLS certificate.

Course Delivery:

HeartCode ACLS is the AHA's blended learning delivery method for the AHA's ACLS Course. HeartCode blended learning delivers quality resuscitation education regardless of where providers are geographically located and gives them more control to complete the course at their own pace. Providers first complete the online portion of HeartCode ACLS, and then complete a hands-on skills session with AHA ACLS Instructors in one of our ACLS training sites.

Candidates cannot attend part 2 unless they show a completion certificate for part 1.

With the introduction of the 2025 ACLS Guidelines, the HeartCode course uses a personalised adaptive algorithm that sets students on the most efficient path to mastery. Students follow a continuously adapting learning path that is personalised by their own inputs: their performance and their self-reported confidence level related to each probing question. The course content is presented in the form of self-directed learning content, probing questions, and Cognitive Assessment Activities (CAAs). Because of the adaptive technology used in these courses, the completion time for the online portion of Heartcode

courses varies based on the student's self-assessment, and objective knowledge of the cognitive material.

ACLS Experienced Provider

Who is the course suitable for?

The AHA's ACLS EP Course is designed for those who are proficient in performing BLS and ACLS skills, reading and interpreting ECGs, understanding ACLS pharmacology and who regularly lead or participate in the emergency assessment and treatment of deteriorating patients.

Course Delivery:

The ACLS for Experienced Providers (ACLS EP) Course aims to expand ACLS knowledge beyond the standard primary and secondary survey.

This course aims to improve outcomes in complex cardiovascular, respiratory as well as metabolic and toxicological emergencies amongst others, by expanding on core ACLS guidelines, and encouraging critical thinking and decision-making strategies.

Through instruction and active participation in case-based scenarios, learners enhance their skills in the differential diagnosis and treatment of deteriorating patients. Training sites who run EP courses must review the *-ACLS for Experienced Providers Course Overview Jan 24* document before running this course.

Course Notification (to Irish Heart Foundation)

If you are planning an ACLS course, you need to give at **least 3 weeks prior notice**. This allows us time to upload your course details onto our system and facilitates the smooth

processing of courses. Please email resus@irishheart.ie with your planned dates and let us know if you wish to have your courses advertised on our website.

If for any reason, your course does not go ahead, please simply email resus@irishheart.ie.

- It is the responsibility of the ACLS Training Site and the course co-ordinator to ensure that all **ACLS faculty** hold **current valid certification** in the appropriate discipline **prior** to conducting the course. Please ensure that all instructors sign the Course Roster form, including their instructor number and card expiry date. Please contact resus@irishheart.ie prior to running your course to check the status of an instructor or medical directors' certification if you are unsure.
- Your **Medical Director's Certification must be in date while directing the course.**
- If instructors require recertification on your course, ensure that a Regional Faculty member will be available to carry out the recertification.
- Medical Director's no longer recertify instructor's

Guidelines 2025

All ACLS Courses must follow G2025 guidelines and must be conducted using the appropriate G2025 ACLS Course timetables, which can be found on the ACLS instructor portal on our website. All courses must follow the instructions and timings directed on the lesson plans.

All videos must be shown as highlighted in the course lesson plans, and as discussed on the ACLS Guidelines workshop, which can be reviewed on our ACLS instructor portal.

All course materials (ACLS manuals, Digital videos, instructor manuals, etc) must be the G2025 version. Please do not use old materials, as this will deem a course invalid.

Candidate Pre-Course Requisites

- ACLS courses are appropriate for candidates who manage or participate in cardiac arrests, or cardiovascular emergencies and must be proficient in:
 - **Performing high quality BLS skills,**
 - **Reading and interpreting ECGs,**
 - **Understanding of the ACLS pharmacology**
 - **Performing bag-mask ventilations**
- Candidates must complete all the necessary pre-course work / MCQs online (or the Heartcode Part 1 online) depending on the course they will be attending.
- <https://ihf.eu.learning.laerdal.com/> using the url access code provided by the training site that they are completing the course with.
- To pass the pre-course work the students must score greater than 70%, and to print their pre-course certificate of completion. This certificate should be submitted to the course co-ordinator prior to attending the course. It is important that the candidates have adequate time to prepare for their course; it is recommended that candidates have all materials **at least three weeks prior the course**. It is also important to ensure that candidates log on to their course at least one-week prior to the course date to ensure that they can complete certification without technical problems. Should a technical issue arise from the candidates please email resus@irishheart.ie with a detailed explanation and screenshot of the problem.
- Candidates must hold current BLS for Healthcare Provider certification or equivalent (e.g. CFR Advanced) at time of their ACLS course. Heartsaver training alone is not adequate for ACLS participation.
- Each candidate must be provided with the most current ACLS course textbook / e-book and this should be available for use before, during and after the course.
- This e- book is already contained in the ACLS Heartcode key.
- Candidates should feel able to complete the physical aspects of the course as required and have informed the course coordinator of any underlying injuries / conditions that may cause them discomfort or concern.

Instructor – Student Ratios

- Maximum instructor – student ratio for ACLS courses is 1 – 3 (2 instructors per station).
- The Medical Director must be present on site for the duration of course.
- If there are over 24 candidates on a course, then in addition to the Medical Director, an ACLS Council Member, Regional Faculty Member or a second Physician Instructor must be present.

- **NB:** Candidate’s skills assessments must be completed as part of the specific assessment lessons in the course and must not be completed during practice/learning stations.

ACLS Provider Exams

- The G2025 exam (as issued to all ACLS sites January 2025) with 50 questions should be used for the written exam. The pass rate is 84%.
- There are two versions of the exam A & B, the second of which may be used for remediation if required.
- The written exam is an open book exam, and candidates can use course resources during the exam, but no discussions may take place during exam time.
- Course coordinators must adhere to a strict time limit of 45mins for the written exam. Please refer to lesson plan T5 and T6 instructor manual.

Remediation

If a candidate is unsuccessful, they can only be offered **one** further opportunity for remediation. This remediation may be done on the day of the course, or within up to six weeks thereafter. If the candidate is unsuccessful once again, they will need to repeat another provider course.

Regarding the MCQs and remediation, if a candidate has not reached 84%, they can be remediated on the questions they missed. If they miss more than two additional questions (i.e. 80% or less) they should be remediated completing the full MCQ exam taking the other version of the exam.

Students must complete all remediation sessions, including tests and skills stations within the 6 weeks of the last day of the original course. **Every student is given the opportunity to remediate.**

For further information on remediation, please refer to your lesson plans page 44 and instructor manual (page 20-21) for steps to successful remediation.

Post Course Student Evaluation

- A course evaluation form must be used on each course to obtain feedback from students on course content, and instructors. This evaluation form should be kept on site for a period of three years and may be reviewed during site visits.
- The evaluation form must be based on the standard form.
- Training sites may use the example of evaluation form found on the instructor portal https://irishheart.ie/wp-content/uploads/2021/09/ACLS_Course_Evaluation_Form.pdf

If additional local information is required, training sites may use their own form.

If a student wishes to feedback directly to the Irish Heart Foundation, they can do so by completing the online form on our website. Please note this form does not replace the normal course evaluation form completed at the end of all AHA courses.

ACLS Medical Directors:

- ACLS Course Medical Directors and Course Coordinators are responsible for quality assurance in the delivery of ACLS training. Medical Directors should also provide guidance and assistance to instructors and candidates as needed during the course.
- ACLS Medical Directors must be in date of their ACLS certification, and have all updates completed before directing ACLS courses.
- It is mandatory that all Medical Directors attend or review IHF workshops.
- Instructors may only proceed to become a Medical Director with the approval of the Irish Heart Foundation. Please email cmcphillips@irishheart.ie
- Medical Directors **must be present on site for the full duration of the ACLS Course and** may also participate in instructing during the course.

Criteria for Role as a Medical Director:

- Must be a currently certified IHF ACLS Instructor.
- Be a Physician Instructor (Senior Registrar level or Consultant level).
- Been a qualified instructor for **at least two years OR taught a minimum of six courses** (which can include the courses on which they observe and are monitored on as part of becoming an ACLS Instructor).
- Instructors who meet the criteria for Medical Director should, with the approval of the Irish Heart Foundation, shadow another Medical Director on a course prior to undertaking the role. It is desirable that Medical Directors should be regularly involved in the management of Cardiac Arrest or deteriorating Patients.
- If a Medical Director needs to be recertified, this can be completed by a regional faculty member.
- Medical Directors no longer carry out recertification of instructors.

ACLS Instructor Courses

- ACLS instructor courses are conducted on an annual basis by the Irish Heart Foundation.
- It is important to note that the purpose of the instructor course is to develop a candidate's instructing ability. Potential instructors must have a high level of ACLS Provider skills. Candidates who are nominated by Training Site Co-ordinators for an instructor course must have an established in-depth knowledge of ACLS course content.

Criteria for Instructor Potential (Please see appendix 6 for checklist page 30)

Selection and status of those with Instructor Potential

- Candidates who show exceptional ability and aptitude on an ACLS Provider course may be considered for Instructor training.
- IP candidates must get approval by majority of faculty at ACLS provider course and require sign off by Course director and Course organiser/RTO
- The IP selection and voting process is set out on the form given to each faculty member
- The faculty's evaluation and voting process for IP must be retained at the end of the course by the Organiser.
- IP status lasts for the period of validity of the provider certificate (2 years).
- IP candidates must have a minimum of 3 years relevant clinical experience.

To be considered for nomination as IP:

- A candidate must be either formally nominated at the final faculty meeting by the Course Director or proposed by a full instructor and seconded by any teaching faculty member.
- The whole faculty should then discuss each nominated candidate's performance using their IP assessment forms, quoting their recorded examples of IP behaviour. Some of this discussion will have taken place in earlier faculty meetings.
- Recommendation for IP should ideally be unanimous, but if not, it becomes a majority decision in which at least two-thirds of the faculty must vote. If the votes from the faculty are tied, the Course Director may make the final decision.
- IP assessment form to be completed and signed by Regional faculty Member if available and course Director.

Post ACLS Instructor Course Requisites

- Following successful completion of the ACLS Instructor Course, it is compulsory for all new Instructor Candidates (I.C.) to attend a (2-day ACLS Provider Course) as a supernumerary instructor, to observe and assist. During this initial course, they should attend all stations and should learn from faculty as much as possible. Please remember that observing Instructor Candidates are **supernumerary** to the instructor – student ratio for the course.
- The I.C. must also attend a second 2-day ACLS Provider Course, during which the I.C. is monitored instructing throughout the course by a Regional Faculty member. The I.C. is again not included in instructor-student ratio but must sign the course roster for attendance purpose.
- Please note there should be a maximum of one new instructor candidate being monitored per station. (For example, 3 stations, 3 instructor candidates, 2 stations 2 instructor candidates). There is no limit to the number of observing instructor candidates for an ACLS Provider Course. However, please be mindful of not creating an intimidating environment for either the I.C.s, or the ACLS Provider candidates.
- These compulsory shadowing and monitored courses may be counted towards the overall four courses that are required to be eligible for recertification as an instructor. Extensions for instructor monitoring and recertification can only be given by the Irish Heart Foundation. Please contact cmcphillips@irishheart.ie to discuss any concerns. Extensions should be requested before certificate expiry date.

Instructor Monitoring & Renewals

- Instructor certification is for two years and expires at the end of the month two years from the date of the initial instructor course for new instructors, or the last renewal date for recertified instructors. Instructors should complete recertification before current certification lapses.
- Certified ACLS Instructors may teach in any of the Irish Heart Foundation affiliated training sites.

- ACLS instructor monitoring/renewals must be conducted by in-date certified ACLS Regional Faculty Members (RF) during an ACLS course.
- Your Regional Faculty member must attend the online RF workshop, IHF/ AHA Guideline workshops and be familiar with all current Resus practices.
- RF should exemplify integrity, demonstrate strong ethics, communicate clearly, and model a dedication to quality of training as well as be proficient in nontechnical skills and possess an aptitude for teaching. They should be able to monitor and coach instructors and instructor candidates in accordance with AHA guidelines and report back to the IHF. RF must strengthen and support the Chain of Survival, embrace and implement the latest AHA guidelines and principles. A RF member collaborates with the IHF to ensure the highest quality training for the programme.
- During initial monitoring of an instructor, please complete the Instructor Monitoring Form (**Appendix 2**). This form can also be found on the instructor portal of our website. <https://irishheart.ie/what-is-cpr/cpr/cpr-instructors-portal-private/>

- For Instructor recertification, a monitor and instructor renewal Checklist form (**Appendix 3**) should be completed. This form can also be found on the instructor portal of our website. <https://irishheart.ie/what-is-cpr/cpr/cpr-instructors-portal-private/>

- Please email these forms to resus@irisheart.ie within 30 days of completion. Once documentation has been processed and verified that all criteria has been met, an instructor card will be issued electronically directly to the instructor.
- Initial monitoring of new instructors (including those applying for reciprocity) can only be done on a standard 2-day ACLS Provider Course.
- Instructor recertification monitoring can be performed on any ACLS courses (Heartcode, ACLS Provider or Renewal).
- Instructors must teach a minimum of four ACLS Provider Courses within the preceding two-year period to be eligible to recertify. These courses must be completed prior to instructor expiry date.
- For an ACLS Instructor to be recertified, the following must be completed:

- Provider skills, including CPR/AED and Megacode, must be successfully demonstrated
- ACLS Provider exam must be completed successfully
- Dates and venues of four ACLS Provider courses taught since last recertification must be provided
- Successful monitoring while instructing on an appropriate course,
- Certificate of guidelines updates, and attendance at relevant workshops held by IHF must be provided
- ACLS EP Instructors who are recertifying must maintain ACLS Instructor status as above, with **a minimum of at least one** of the required four provider courses taught being an ACLS EP course.
- A maximum of three new instructors can be monitored teaching on an ACLS Provider course.
- There is no limit to the number of ACLS Instructor recertification's which can be done on an ACLS Provider Course.

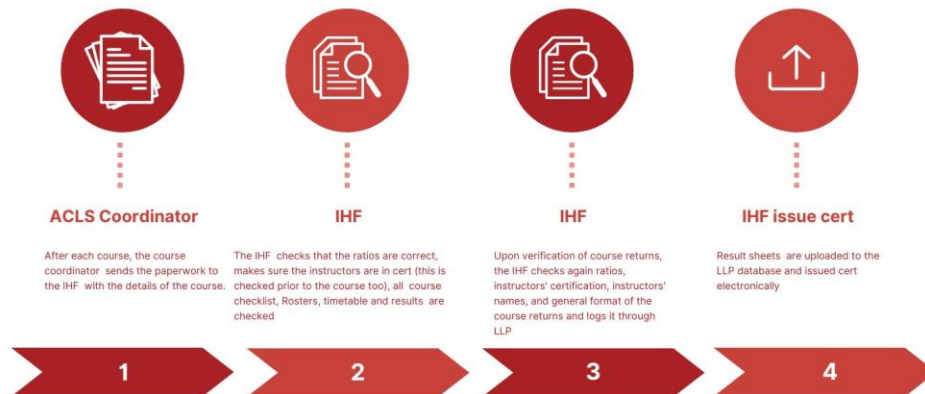
AHA Instructors seeking reciprocity:

- ACLS instructors from other AHA approved International Training Centre (I.T.C.) must request that a copy of their training records be forwarded to the Irish Heart Foundation by completing the ***Instructor Records Transfer Request form*** (which can be requested from resus@irishheart.ie). The completed form should be emailed to the Irish Heart Foundation for completion. This form should then be forwarded by the instructor to their previous ITC.
- Following receipt of all information and approval by the I.H.F., an ACLS instructor can proceed to complete observation as a supernumerary instructor on a two-day ACLS Provider Course, followed by being monitored by an RF member on a second standard two-day ACLS Provider Course.

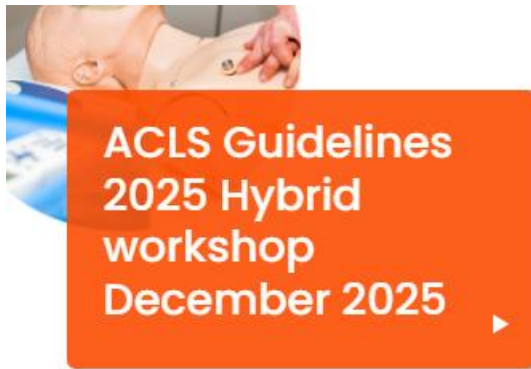

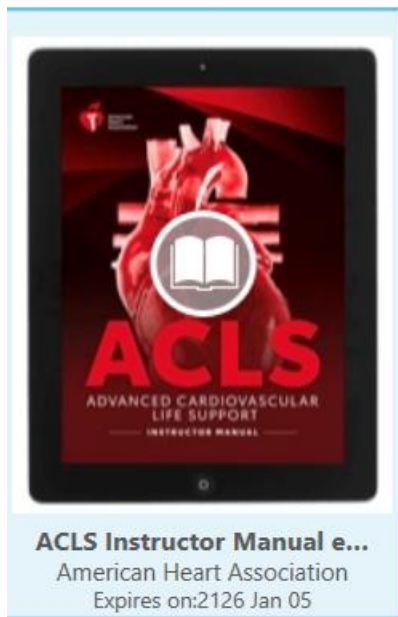

IHF ACLS Council Instructor Criteria 2026

Selection and status of those with Instructor Potential

- Candidates who show exceptional ability and aptitude on an ACLS Provider course may be considered for Instructor training.
- IP candidates must get approval from the majority of faculty at ACLS provider course and require sign off by Course director and Course Co-Ordinator /RTO
- The IP selection and voting process is set out on the form given to each faculty member
- The faculty's evaluation and voting process for IP must be retained at the end of the course by the Co-Ordinator.
- IP status lasts for the period of validity of the provider certificate (2 years).
- IP candidates must have a minimum of 3 years' relevant clinical experience.

To be considered for nomination as IP:

- A candidate must be either formally nominated at the final faculty meeting by the Course Director or proposed by a full instructor and seconded by any teaching faculty member.
- The whole faculty should then discuss each nominated candidate's performance using their IP assessment forms, quoting their recorded examples of IP behaviour. Some of this discussion will have taken place in earlier faculty meetings.
- Recommendation for IP should ideally be unanimous, but if not, it becomes a majority decision in which at least two-thirds of the faculty must vote. If the votes from the faculty are tied, the Course Director may make the final decision.

Instructor Potential (IP)

The aim is to identify candidates who are good teachers and those who have the potential to become good teachers. Excellent ACLS provider knowledge and skills is a prerequisite.

The following criteria are used to identify candidates with Instructor Potential qualities:

1. Communication skills

- **Basic**

Communicates effectively and appropriately; aware of his/her audience.

- **Advanced**

Active listener: uses vocal factors in speech, such as tone of voice, tempo of speech; makes insightful comments; avoids redundancy and repetition.

2. Commitment to ACLS

- **Basic**

Prepared for course, full participation.

- **Advanced**

Willingness to take on instructor responsibilities; demonstrated during informal discussion or mentoring sessions.

3. Credibility as a teacher

- **Basic**

Knowledgeable and able to communicate knowledge.

- **Advanced**

Higher level perception, awareness and understanding in relation to ACLS content; able to contribute to ongoing developments; capacity for adding value to the course.
May be demonstrated during informal discussions, feedback, and mentoring sessions.

4. A team player

- **Basic**

Recognises contributions of other team members during code

- **Advanced**

Good interpersonal skills; able to get best from people as leader and member.

5. Feedback (not essential for IP, but positive if demonstrated)

- **Basic**

Insightful and accurate.

- **Advanced**

Effective engagement and dialogue; willing to address complex issues (will only be evident if complex issues have emerged when this person is 'Observer')
